



MONTHLY PARKING PERMIT INFORMATION COLORADO CONVENTION CENTER *PARKING MANAGEMENT*

The Colorado Convention Center provides on-site vehicle parking in our 1,000 space parking garage for monthly parking. The following information is provided to assist downtown residents and commuters in the monthly parking options at the Convention Center.

PERMIT PRICE: [\\$100 per month](#)

GARAGE LOCATION: The garage is located at the Colorado Convention Center.

VEHICLE ENTRANCE: Enter the parking garage **via North-bound Speer Boulevard** just after Stout Street and before Champa Street. The convention center parking garage has its own designated Right Turn deceleration lane leading into the parking garage. Vehicle clearance is 8'2" and the maximum vehicle length is 19'0".

GARAGE HOURS: The parking facility is open 24 hours a day, 7 days a week. Unlimited access to/from the garage is provided (no gate or proximity card needed) to all monthly permit holders. Should the garage be full due to high event activity, simply display your permit to the attendant and access into the garage will be granted. Space in the garage for monthly permit holders is always reserved.

DESIGNATED MONTHLY PARKING AREA: Monthly parkers are assigned to parking [level P2](#), with overflow occurring on parking level P3. Permit holders may park in any non-reserved parking space on level P2. Covered permit parking is not guaranteed.

SECURITY: Parking staff as well as convention center security patrol the garage daily and also monitor a number of camera positions in and through the garage.

HOW TO PURCHASE A PERMIT: There are two (2) methods by which individuals may purchase a parking permit:
1.) Directly From A Pay Station or 2.) Purchase A Plastic Hang Tag With Monthly Invoicing.

1.) Pay Station Permit Purchase Instructions:

At any time (24 hrs. a day, 7 days a week), a Monthly Permit can be purchased directly from any automated pay station located throughout the garage by using a major credit card. Select "Monthly Permit" from the main screen and simply follow the instructions. The printed receipt or "Permit" is required to be displayed on your vehicle dashboard while parked in the garage. The permit will be valid for 30 days from the purchase time. For example, a permit purchased on August 14th at 2:30am will expire on September 14th at 2:30am. This option is the best option if you anticipate only parking with us for a few months. This is also a great option to test us out to see if you like parking with us. If you enjoy the facility, keep purchasing a permit from the machines or just purchase a plastic hang tag (option #2 below) when your paper receipt/permit expires.

2.) Purchase A Plastic Hang Tag With Monthly Invoicing Instructions:

For individuals who know they will be parking with us for an extended period, we offer a plastic hang tag option that is renewed and invoiced monthly. Simply schedule a quick purchase time with the Parking Manager by calling 303.228.8070. A short application is completed and a plastic rear view mirror hang tag is issued. At the time of purchase, you will be charged the pro-rated amount for the current month. The convention center will invoice you monthly with parking fees due by the 1st of every month. Credit card transactions are **not** available with this option.
